Vendors will not surround the park but be put into rows. There will be live music

- *Vendor Entry: 6:00 AM . All vendors must be unloaded by 10:30 am, July 6, 2019. Event is rain or shine.
- *Vendor agrees to abide by all show rules, policies and procedures printed and incorporated in this application/ contract. Signature of this contract indicates that the person signing accepts personal liability for his/her company.
- *Vendor must remain set up until close of show Saturday, July 6, 2019 at 5 pm. Failure to comply will result in loss of future exhibiting privileges.
- * Vendors shall supply all the furnishings: tables, chairs, canopy, tents, ext. Only ground space is provided by the event.
- *All tents must be weighted and/or secured.
- *You must leave the space you are rented in the clean condition that you found it in. No garbage is to be left behind.
- *Non Food Vendor space is \$25 for a 10 by 10 foot space.

*All booths are assigned on a first come, first served basis. There are no drive up vendors allowed The funds MUST be in US dollars and be paid in full with contract and no later than July 4, 2019,. Vendor space is limited and entry might be closed sooner than July 4, 2019. Payment should be sent in with completed application.

RULES & REGULATIONS Show management reserves the right to enforce strict compliance with all rules and regulations, exceptions to the following rules and regulations will not be permitted.

1. **SPACE ASSIGNMENT:** Management reserves the right to determine booth location. Booth sharing is not permitted without consent of management. Exhibitor may not assign their booth or any portion thereof to any other person for any reason.
2. **BOOTH FEES:** Vendor space is limited and vendor applications may close early due to demand. A payment must accompany a signed contract to be valid by July 1, 2019. Exhibitor will not be allowed to occupy any booth not fully paid for. In such case, any exhibit space money received shall be considered a nonrefundable deposit.
3. **DISPLAY REGULATIONS** No exhibit may block or interfere with a neighboring exhibit. Exhibitors shall confine all exhibit activities within the limits of the booth. Absolutely no exhibits are permitted outside the contracted booth space without express written permission from Management.
4. **VENDOR SETUP:** Vendors may arrive as early as 6:00 am on July 6, 2019 and must be in the park and unloaded by 9:30 am. No early packing may be started before the show closing on Saturday, July 21, 2018, at 4 pm. Any vendor using the services of an independent decorating company assumes all liability for the acts of that decorator during installation or dismantling under this contract.
6. **STAFFING:** Booth and table spaces must be staffed at all times. Management shall have the authority to adopt and enforce all rules and regulations regarding booth staffing.
5. **VENDOR RESPONSIBILITIES:** Vendor agrees to comply with all applicable local, federal, and state tax and other laws relating to the sale of goods or services, and to obtain, pay for, and display all necessary licenses and permits, and to pay all taxes and levies in so far as the food truck's own participation in the Show is concerned.
- 6 **CANCELLATION CLAUSE:** Any vendor wishing to cancel event space reservation for reasons of their own may do so in writing. A 50% refund on show space will be granted up to and including May 15, 2018. Any cancellation after May 15, 2018, will be accepted, but no refund of event space money will be made.
7. **AMENDMENTS** Management shall have full power in the interpretation and enforcement of all contract regulations contained herein, and the power to make such amendments thereto, and such further rules and regulations as shall be considered necessary for proper conduct of the exhibition. All food trucks will be promptly notified of any changes to these rules.
